
1. Board signed the following:

2. A motion was made, seconded and all were in favor to accept the meeting minutes for December 22, 2020.
3. The Board reviewed the Title V report for 86 Batchelor Street submitted by Neil Jackson of J & P Engineering Services. The Board received the report as a pass.
4. The Board reviewed the Title V report for 76 Kendall Street submitted by Neil Jackson of J & P Engineering Services. The Board received the report as a pass.
5. Ryan Pease submitted an application for a new disposal system construction permit at Lot 1 Amherst Street. The plans are for a 5 bedroom home. The Board reviewed the plans. The Board approved the application subject to fill, electrical permit and plumbing permit.

6. Alan Weiss submitted an application for a new disposal system construction permit at Lot 4 Easton Street. The plans are for a 3 bedroom home. The Board reviewed the plans. The Board approved the application subject to fill, and submission of a modified drawing.
7. The Board discussed the two front basins at Dollar General. Dick observed the two front basins were full to the level of the overflow to the street storm basin. Water was flowing into the upper basin from the green subsurface drain system. The Board instructed Colleen to call Dollar General and make them aware the subsurface drain should not be there.
8. Gary Turnberg was present to request an Installer's license. After discussion the Board granted the 2021 Installer's license.
9. Chief Wishart, and Lt. O'Grady were present to discuss the COVID-19 vaccinations for first responders. Some EMS received their first shot. Other First Responders will be vaccinated at a site, in Amherst, next week.
10. The Board discussed vaccine distribution. All agreed it was too big an undertaking for a small town to set up vaccine distribution in isolation for the town.
11. The next regular Board of Health meeting will be held on January 19, 2021 via conference call/zoom.
12. The Board adjourned the meeting at 7:45 pm.
