The regular meeting of the Granby Board of Health was held by conference call/Zoom and opened at 7:00 pm.

4. The Board discussed the departmental review of the site plan for 81 Pleasant Street for the Planning Board. The Board stated that they would like the Planning Board to not


grant the approval until a plan is submitted stating what the intended activity is and the plan for ground water protection, water and waste disposal.

5. The Board discussed the departmental review of the site plan for 39 West State Street for the Planning Board. The Board stated that they would like the Planning Board to not grant the approval until a plan is submitted stating what the intended activity is and the plan for ground water protection, water, waste disposal and leaking vehicle fluids.
6. The Board discussed the FY23 Budget proposal. The Board agreed to submit the budget with Dick's suggestions and a bottom line 3% increase.
7. The Board discussed fees and charges for Board of Health services possibly being lower than surrounding towns. Colleen was instructed to survey Health Departments in nearby towns for their current fees and charges.
8. The Board discussed the mask mandate. The Board decided to continue the current mask order in place.
9. The Board discussed shared services through the Public Health Excellence Grant. Dick spoke with Merridith O'Leary, Health Director of Northampton. The Board decided to try to find a firm that may be interested in reviewing septic designs for not only Granby but also Northampton and other towns that need help with reviews. Dick will call Merridith to discuss.
10. The next regular Board of Health meeting will be held on December 21, 2021, 7p.m. via conference call/zoom.
