

## THE TOWN OF GRANBY BOARD OF HEALTH MINUTES February 15, 2022

The regular meeting of the Granby Board of Health was held by conference call/Zoom and opened at 7:00 pm.

Absent, Herb Abelson

Those in attendance were, Alan Weiss, Daphne Kamenides, Kevin & Nancy Brooks, Gayle DeMary, Dakota Richards, John Kopinsky, Madison Walker, Peter White, Kim Bernier.

1. The Board voted on and unanimously approved individually each of the following items:

Timesheet for Colleen

Money Turnover Sheet

Bill for Quill office supplies, Tom Flebotte invoice and Brett Lord invoice.

- 2. Dan Marinello from Fletcher Sewer and Drain was present to request a new 2022 Hauler's License. Mr. Marinello stated that the company would be dumping at the Town of Palmer wastewater plant. They have a three year contract to do so. After discussion, the Hauler's License for Fletcher Sewer & Drain was approved by both members of the Board.
- 3. The Well Permit application for lot 13 School Street was not approved. Madison Walker, owner, was present. The Board informed Ms. Walker there needs to be an approved septic design first. The Board instructed Colleen to call Cushing & Sons Well Drillers and inform them the permit is not approved and to hold off on the well installation.
- 4. A motion was made, seconded and all were in favor of accepting the meeting minutes for January 18, 2022 and February 1, 2022.
- 5. Title 5 Inspection Reports were received by the Board: 12 Griswold Circle, Neil Jackson, Fails
- 6. Neil Jackson submitted a complete system replacement septic design for a 3-bedroom house at 13 Pineview Circle. The Board did not approve the design due to the 10' setback of SAS to house as it should be 20'.
- 7. Neil Jackson submitted a complete system replacement septic design for a 3-bedroom house at 12 Griswold Circle. The review was complete. Both members of the Board approved the application subject to submission of revised drawing with adjacent wells located, fill and trench permit.

- 8. John Kopinsky submitted a new complete system septic design for a 3-bedroom house at 108-110 Morgan Street. The review was complete. Both members of the Board approved the application subject to submission of revised drawing with relocated SAS, elevation changes, SAS observation hole requirement, fill, trench permit and verification hole in SAS at time of sub strip.
- 9. Kevin & Nancy Brooks were present to request the Board to re-instate the septic permit approval at 220 West State Street. The Brooks stated that the new well was installed according to the plan and the other well had been decommissioned. Both members of the Board voted to re-instate the application approval. The Board authorized Colleen to send a letter stating the Boards decision.
- 10. Alan Weiss was present to discuss 141 East Street. Alan had submitted a 2-bedroom complete system replacement septic permit application. The fee was not paid. The review was not complete. Alan was requesting a decision on the number of potential bedrooms. After discussion with the owner, it was determined that the sketch of the dwelling, submitted by Alan, was incorrect. The number of potential bedrooms was not determined.
- 11. Micheline Turgeon requested by email a letter from the Board stating that lot 1 is a suitable for a Title 5 septic system. The Board authorized Colleen to send the letter that Dick prepared.
- 12. Both members of the Board decided to discuss the school mask use at its March 15<sup>th</sup> meeting. The decision was supported by the administrations of both the Public Schools and MacDuffie School. The decision was made considering, high student transmission during the holiday break, low Granby student vaccination rates, high Granby positivity and case rates and high Granby CDC transmission risk level.
- 13. The next regular Board of Health meeting will be held on March 1, 2022, 7p.m. via conference call/zoom.
- 14. The Board adjourned the meeting at 8:15 pm.
