BOARD OF HEALTH MINUTES
December 22, 2020

The regular meeting of the Granby Board of Health was held by conference call/Zoom and opened at 6:30 pm.

2. A motion was made, seconded and all were in favor to accept the meeting minutes for December 8, 2020.
3. The Board reviewed the Title V report for 286 Batchelor Street submitted by Greg Everson of Granby Septic Service. The Board received the report as a pass.
4. The Board reviewed the Title V report for 169 Chicopee Street submitted by Neil Jackson of J & P Engineering Services. The Board received the report as a pass.
5. The complaint regarding vehicles at 242 State Street was discussed. Lee provided information but abstained from the discussion or decision. The Board closed the case as two of the three vehicles have been removed from the property and the tractor has a


dry crank case. The tractor will remain in that location at the owner's discretion. Lee stated that the soil under all three vehicles was examined by Alan Weiss, a soil scientist and determined to be free of any contamination that could have been released from the vehicles.

6. Nancy Jenks was present to discuss COVID issues. Nancy and the Board discussed a clearance letter. The Board agreed the clearance to return to school should be in written form. The schools will be remote the week after New Year's with the special needs students engaging in face to hybrid instruction with extra screening of the involved families. The Board supported this decision.
7. Chief Wishart, Lt. O'Grady and Gene Os were present to discuss the COVID-19 vaccinations for first responders. The state is working on a distribution plan but nothing is set up yet. Dick spoke with Sharon Hart of South Hadley BOH about two possible locations for distribution, Beers and Story Funeral Home or the Second Baptist Church on Rt 202. The state may choose a central location such as UMASS. Gene will be following up with Sharon on the 23rd.
8. The next regular Board of Health meeting will be held on January 5, 2021 via conference call/zoom.
9. The Board adjourned the meeting at 7:10 pm.




