

## THE TOWN OF GRANBY BOARD OF HEALTH MINUTES November 16, 2022

The regular meeting of the Granby Board of Health was held by conference call/Zoom and opened at 7:00 pm.

Those present were Dick Bombardier, Lee Lalonde, and Bill Shaheen Those in attendance were Neil Jackson, Jill & Robert Cafarelli, Steve Brunetti

- 1. A motion was made, seconded and all members were in favor of accepting the meeting minutes for October 25, 2022.
- 2. The Board voted on and all members approved each of the following items:

- 3. The Board members, unanimously received these Title 5 Reports:
  - 187 West Street, Dave Kibbe, Passes
  - 144 Carver Street, Greg Everson, Passes
  - 150 Amherst Street, Neil Jackson, Passes
  - 61 North Street, Neil Jackson, Passes
  - 549 Amherst Road, Neil Jackson, Passes
  - 11 Leo Drive, 29, 30, 37, 41 Kellogg Street, Neil Jackson, all Passes
- 4. Neil Jackson was present to submit a revision to a previously approved well and septic design for a new 3-bedroom, complete system, at lot 1, Amherst Street. The review was completed. The Board approved the revision to the design.
- 5. Neil Jackson also submitted a septic design for a 3- bedroom, new construction, complete system at lot 8 Cold Hill. The review was completed. The Board approved the design subject to fill and trench permit.

- 6. Jill and Robert Cafarelli were present to submit a septic design repair for a 2-bedroom house at 21 West Street. The review was not completed. The owner requested approval of the design, as submitted. After discussion, the design was rejected due to no soil evaluator and the owner must speak with Conservation Commission regarding the wetlands. The Chair reminded the Cafarellis that septic design reviews are done offline, not during meetings.
- 7. The Cafarellis also submitted a septic design repair for a 4-bedroom house at 291 East State Street. On file is an approved 3-bedroom design. The review was not completed. A local upgrade approval was requested for the existing well that is 55' to the leach field. After discussion, the Board did not grant the request for the well to be closer than 100' to the leach field. The design was not approved.
- 8. The Board re-appointed Lynn Diniz as alternate Health Inspector for a 3-year term.
- 9. The Board discussed the hauler's application that DEP supplies for local Boards of Health to use. The Board would like to use this application going forward.
- 10. The Board discussed the request by the Select Board regarding a Senior work-off program. The Board discussed a plan to digitize information for the State. To do this, a computer, software, research and supervision would be required. The Board instructed the Assistant to respond to the Select Board with this information.
- 11. The Board discussed the request from the Library Director for signage for sick patrons coming into the library. The Board suggested, they post a sign reading, The Season is here for RSV, COVID and Flu. With cases increasing, the Board of Health requests that individuals with symptoms not use this building and suggests wearing masks while in the library. The Board also suggested that library staff wear masks when not in their own offices.
- 12. The next regular Board of Health meeting will be held on December 6, 2022, 7p.m. via conference call/zoom.

13. The Board adjourned the meeting at 8:30 pm.
