Letter from the Commonwealth of Massachusetts

Robert Camus read a letter from the Massachusetts Historical Commission announcing the beginning of their Fiscal Year 2017 Survey and Planning Grant cycle. The letter noted the available funding is "contingent on MHC's FY17 federal budget allocation, which has not yet been determined. For FY 2017 the MHC/Grantee match shares are 50/50." The deadline for any applications is November 14, 2016.

The Commission discussed potential uses for a grant and in the end decided to add this topic to the next meeting for voting.

Aldrich Hall and Selectboard Request for Certificate of Appropriateness

The Commission discussed the September 30, 2016 letter from Chris Martin on behalf of the Selectboard asking for a favorable vote regarding demolition of Aldrich Hall.

The Commission discussed the letter with members voicing their opinions on whether or not to approve the request.

Motion was made by Steve Nally and seconded by Kathleen Morris to grant the application for the Certificate of Hardship for Aldrich Hall. The motion did not pass with a vote of 2 in favor, 3 opposed, 0 abstained.
