Jim Trompke received a notice today at about 2 p.m. from the Project Manager who had forgotten to give advance notice to the Planning Board. The meeting will be held in the Learning Center of the East Meadow School.

The Board discussed asking Larry Smith to attend, but the notice was too short. Jay Joyce has another meeting but will try to attend if he gets out in time. Robert Sheehan, Jr. said Jim Trompke noted there would be another meeting if no one from the Planning Board could attend the February 28 meeting.
