CALL TO ORDER: Glen Sexton called the meeting to order at 5:02 p.m.

Old Business and Information

<u>Dollar General – Stormwater</u>

Jim Trompke updated the Board on his meeting with the Building Inspector, Town Counsel and the Board of Health. Town Counsel determined it was well within the Planning Board's rights to recommend to the Building Inspector a permanent certificate of occupancy not be granted until the recommendations from Tighe & Bond are met.

Chad Brubaker reported work was going to start with General Contractor on Monday, June 15, 2020. Work should be commenced and completed by mid-week.

Lillian Camus asked when the work recommended by Tighe & Bond will be completed. Chad Brubaker responded by the end of this next week.

Greg Briggs noted that once things are done to the extent that Tighe & Bond has recommended he does not see any reason to not issue a Certificate of Occupancy.

ANR - Carver Street - Blanchet

The Board reviewed an ANR from Michael P. Blanchet and Anne Blanchet. Deed of property recorded in Hampshire County Registry of Deeds in Book 13458, Page 218.

Jim Trompke spoke with Town Counsel who said it was fine for the Planning Board to sign the Blanchet ANR even though the owner of the property is not the applicant on the ANR form. The Blanchets can record it as it is not a transfer of deed. They need a deed and purchase and sale to make it stick.

Motion made by Jim Trompke and seconded by Robert Sheehan, Jr. to approve the ANR submitted by Michael and Anne Blanchet. Motion carried 5 in favor 0 opposed and 0 abstained.

<u>Guy & Charlotte Cote – Oversized</u> Barn

The Board reviewed a draft of the Site Plan Approval sent by Ken Comia.

Motion made by Robert Sheehan, Jr. and seconded by Lillian Camus to approve and sign the Guy & Charlotte Cote Site Plan Approval. Motion carried 4 in favor 0 opposed and 1 abstained (Jim Trompke).
