#### Minutes

CALL TO ORDER: Jim Trompke called the meeting to order at 5 p.m.

## **Administrative Items**

<u>Approval of September 14, 2020 Minutes</u> Jim Trompke asked if there were any changes to the September 14, 2020 minutes. Hearing none,

Motion was made by Robert Sheehan, Jr. and seconded by Lillian Camus to approve the September 14, 2020 minutes as written. Motion carried 4 in favor, 0 opposed, 0 abstained

<u>Approval of September 15, 2020 Minutes</u> Jim Trompke asked if there were any changes to the September 15, 2020 minutes. Hearing none,

Motion was made by Robert Sheehan, Jr. and seconded by Lillian Camus to approve the September 15, 2020 minutes which were the Joint Meeting of the Planning Board and the Economic Development and Growth Committee. Motion carried 3 in favor, 0 opposed, 1 abstained (Rob Chauvin)

# <u>Approve Bills</u>

## Review Billing

Lillian Camus reviewed billing for projects reviewed by the Board.

- Granby DG Series, LLC Site Plan Approval
  - Motion made by Robert Sheehan, Jr. and seconded by Lillian Camus to send an invoice to Granby DG Series, LLC Site Plan Approval for \$2,991.89 plus any additional interest in Escrow since May 2020. Motion carried 4 in favor, 0 opposed and 0 abstained.
- Granby DG Series, LLC Signs Special Permit
  - Motion made by Robert Sheehan, Jr. and seconded by Rob Chauvin to send an invoice to Granby DG Series, LLC Signs Special Permit for \$1,664.25. Motion carried 4 in favor, 0 opposed and 0 abstained.
- Borrego Solar Special Permit and Site Plan Approval
  - Motion made by Robert Sheehan, Jr. and seconded by Rob Chauvin to send a check to Borrego Solar for Special Permit and Site Plan Approval in the amount of \$305.50 plus any additional interest in Escrow since May 2020. Motion carried 4 in favor, 0 opposed and 0 abstained.
- William Clark Invoice #20-01 Site Plan Approval for Oversized Barn
  - Motion made by Robert Sheehan, Jr. and seconded by Rob Chauvin to approve sending Invoice #20-01 in the amount of \$727.38 to William Clark for an oversized barn on his Batchelor Street property. Motion carried 4 in favor, 0 opposed and 0 abstained.
- Guy & Charlotte Cote Invoice #20-02 Site Plan Approval for Oversized Barn
  - Motion made by Robert Sheehan, Jr. and seconded by Rob Chauvin to approve sending Invoice #20-02 in the amount of \$876.95 to Guy & Charlotte Cote for an oversized. Motion carried 4 in favor, 0 opposed and 0 abstained.
- Sharon Lehmann and Audrey Walker Invoice #19-09 Special Permit
  - The Board discussed how much square footage was involved with the project. Jim Trompke computed it to be 387 sq. ft.
  - Motion made by Lillian Camus and seconded by Robert Sheehan, Jr. to approve sending Invoice #19-09 in the amount of \$545.95 to Sharon Lehmann and Audrey Walker for a Special Permit. Motion carried 4 in favor, 0 opposed and 0 abstained.
- Granby Solar, LLC (Dickinson Farms) Modification Amendment to Site Plan Approval
  - The Board discussed billing which included computing the sq. ft. of the structures. Jim Trompke suggested sending a letter to Greg Briggs asking him to hold the permit to operate until the Planning Board has an "as built" and an invoice from the Planning Board for charges incurred during the Site Plan Approval has been paid.
  - Lillian Camus will create the letter and send to Cathy Leonard to print and Jim Trompke to sign.
- CPV Red Rock Solar Special Permit and Site Plan Approval
  - The Board discussed the issue of computing square footage as none of the plans submitted has that information. After discussion,
  - Motion made by Lillian Camus and seconded by Robert Sheehan, Jr. to waive the charge of \$0.10 per sq. ft. as we do not have any plans showing square footage, and invoice CPV Red Rock Solar \$2,293.24 plus any additional interest in Escrow since May 2020. Motion carried 4 in favor, 0 opposed and 0 abstained.

## **New Business**

<u>ANR – 151 Taylor Street</u> Robert Sheehan, Jr. recused himself from the discussion.

Jim Trompke informed the Board he has family involved in this transaction which belong to the organization. As Robert Sheehan, Jr. has recused himself, Jim is invoking the Rule of Necessity and will give his opinion and vote to have a quorum.

The Board reviewed an ANR from Living Gate Community Church, presented by Stephen Laplante, to section off Lot A from the remaining property. Deed of property recorded in Hampshire County Registry of Deeds in Book 1587, Page 360.

Lillian Camus noted that Cathy Leonard received check #7815 in the amount of \$250.00 dated September 3, 2020 from M. Connie Laplante Real Estate

Motion made by Lillian Camus and seconded by Rob Chauvin to approve the ANR presented by Stephen Laplante on behalf of Living Gate Community Church to section off Lot A from the remaining property. Motion carried 3 in favor 0 opposed and 1 abstained (Robert Sheehan, Jr.)

Jim Trompke signed the plans. Lillian Camus and Rob Chauvin will stop by the Senior Center to sign the updated ANR plans when they are received by Cathy Leonard.

DLTA Project Work Group

The Board discussed who from the Planning Board would be part of the DLTA Project Work Group.

Motion made by Robert Sheehan, Jr. and seconded by Rob Chauvin to appoint Jason Smigiel and Lillian Camus to the DLTA Project Work Group. Motion carried 4 in favor, 0 opposed and 0 abstained.

<u>Continue Discussion on Bylaw Amendments and Zoning</u> Discussion was postponed to later meetings as no Special Town Meeting will be held before next year.

### **Any Other Business**

Lillian Camus noted the date of the Board's regularly scheduled meeting is Monday, October 12, 2020 which is also Columbus Day and may be a Town holiday. After discussion, the Board decided to wait until Monday, October 26, 2020 to meet, unless Cathy Leonard receives items the Board would need to discuss, review and/or vote on.
