## **New Business**

#### ANR – Fred Ruel Road

The Board reviewed an ANR from Daniel and Kathleen Massey. Deed of property recorded in Hampshire County Registry of Deeds in Book 2362, Page 221 (Parcel 1 and 2) and Book 2868, Page 249 (Parcel 3).

Lillian Camus noted that Cathy Leonard received check #1457 in the amount of \$250.00 dated October 9, 2020 from Daniel and Kathleen Massey.

The Board was unclear as to exactly what was being changed. Lillian Camus will ask Cathy Leonard to contact Mr. Massey to attend a Planning Board meeting to answer questions from the Board.

## **Old Business**

### ANR – Harris Street

The Board reviewed an ANR from Heather Laborte to modify property lines for 149 and 151 Harris Street from 145 Harris Street property. Deed of property recorded in Hampshire County Registry of Deeds in Book 1905, Page 262.

Lillian Camus noted that Cathy Leonard received check #4321 in the amount of \$375.00 dated October 22, 2020 from Heather Labonte.

Lillian Camus asked if the land was in Chapter 61. Heather Laborate confirmed some of the land is considered Chapter 61 and was told by the Assessors Office that the boundary line for Chapter 61 is fluid so it was unclear what portion of the lots in question were in Chapter 61.

The Board discussed the Town's Right of First Refusal for Chapter 61 land that is being sold or the use changed. As this property is not being sold or the use changed, the Town's Right of First Refusal does not come into play.

Motion made by Robert Sheehan, Jr. and seconded by Rob Chauvin to approve the ANR on Harris Street which involves resident 145/149/151 Harris Street. Motion carried 5 in favor 0 opposed and 0 abstained
