## Poltrans, Inc. - Public Hearing

Harrop (Owner), seeking Site Plan Approval under Section 6.3 of the Granby Zoning Bylaws regarding a proposed truck parking and dumpster area for the purpose of overnight parking for 10 trucks and the storage of empty dumpsters, approximately 13,083 square feet of gravel, at 4, 6 & portion of 8 West State Street, and known as Assessors' Map 4, Parcels 3, 2-2, 6-1 in the town of Granby, MA. The zoning district is Industrial.
