Granby Solar LLC – Dickinson's Farm

The Board discussed whether the application should be considered as the Town has a moratorium on new solar projects. The Board also discussed whether the application submitted is considered a revision to the original request or an entirely new project.

Glen Sexton will ask Chris Martin to have Town Counsel clarify how the Solar Moratorium would impact the changes proposed by Granby Solar LLC.

 - Added a Bylaw Number column
 - Edit notations so they are consistent throughout Table 1.
