LEGAL NOTICE
PUBLIC HEARING
TOWN OF GRANBY

The Select Board will hold a Public Hearing on Monday February 12, 2024, at 5:31 PM at the **Senior Center Building located at 10-B West State Street, Granby, MA to grant permission to Massachusetts Electric Company d/b/a NATIONAL GRID to locate poles, wires, and fixtures, including the necessary sustaining and protecting fixtures, along and across the following public ways:

Morgan Street - National Grid to install 2 SO poles on Morgan Street beginning at a point approximately 1332 feet South of the centerline of the intersection of Pleasant Street and continuing approximately 84 feet in a Southerly direction. Install 1 SO pole to provide service for new home # 29 and install 1 SO midspan pole to correct long span and low wires along the road in Granby, MA. Location approximately as shown on plan.

Wherefore it prays that after due notice and hearing as provided by law, it be granted a location for and permission to erect and maintain poles and wires, together with such sustaining and protecting fixtures as it may find necessary, said poles to be erected substantially in accordance with the plan filed herewith marked — Morgan Street - Granby, Massachusetts. **NO.# 30922230**

Also, for permission to lay and maintain underground laterals, cables, and wires in the above or intersecting public ways for the purpose of making connections with such poles and buildings as each of said petitioners may desire for distributing purposes.

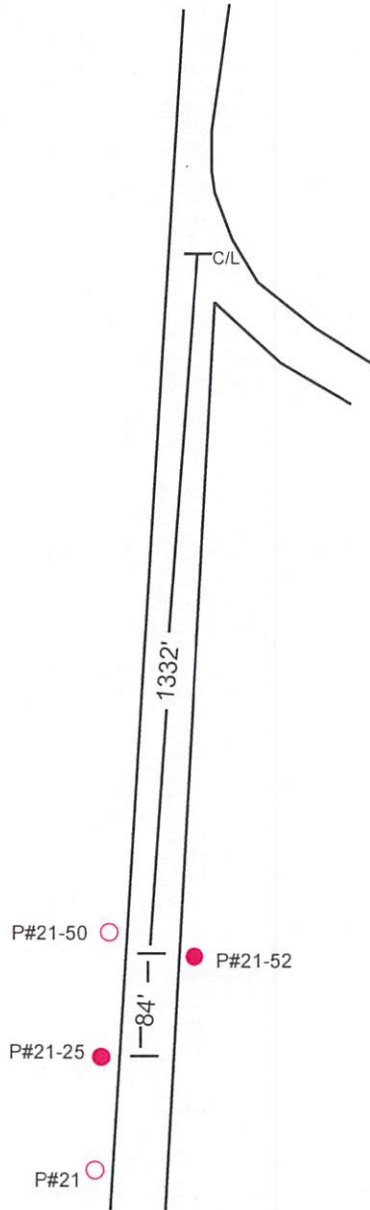
Your petitioner agrees to reserve space for one cross-arm at a suitable point on each of said poles for the fire, police, telephone, and telegraph signal wires belonging to the municipality and used by it exclusively for municipal purposes.
