LEGAL NOTICE
PUBLIC HEARING
TOWN OF GRANBY

The Select Board will hold a Public Hearing on Monday February 12, 2024, at 5:41 PM at the ****Senior Center Building located at 10-B West State Street, Granby, MA to grant permission to Massachusetts Electric Company d/b/a NATIONAL GRID to locate poles, wires, and fixtures, including the necessary sustaining and protecting fixtures, along and across the following public way:**

*Porter Street - National Grid to install 2 SO poles on Porter Street beginning at a point approximately 369 feet South of the centerline of the intersection of Batchelor Street and continuing approximately 75 feet in a Southerly direction. Install 1 SO stub pole to support construction that is now being supported with a tree guy in bad condition and continue —75 feet South install 1-SO pole to correct low service to house # 172, Granby, MA.
Location approximately as shown on plan attached.*

Wherefore it prays that after due notice and hearing as provided by law, it be granted a location for and permission to erect and maintain poles and wires, together with such sustaining and protecting fixtures as it may find necessary, said poles to be erected substantially in accordance with the plan filed herewith marked — Porter Street - Granby, Massachusetts. **No.# 30918196**

Also, for permission to lay and maintain underground laterals, cables, and wires in the above or intersecting public ways for the purpose of making connections with such poles and buildings as each of said petitioners may desire for distributing purposes.

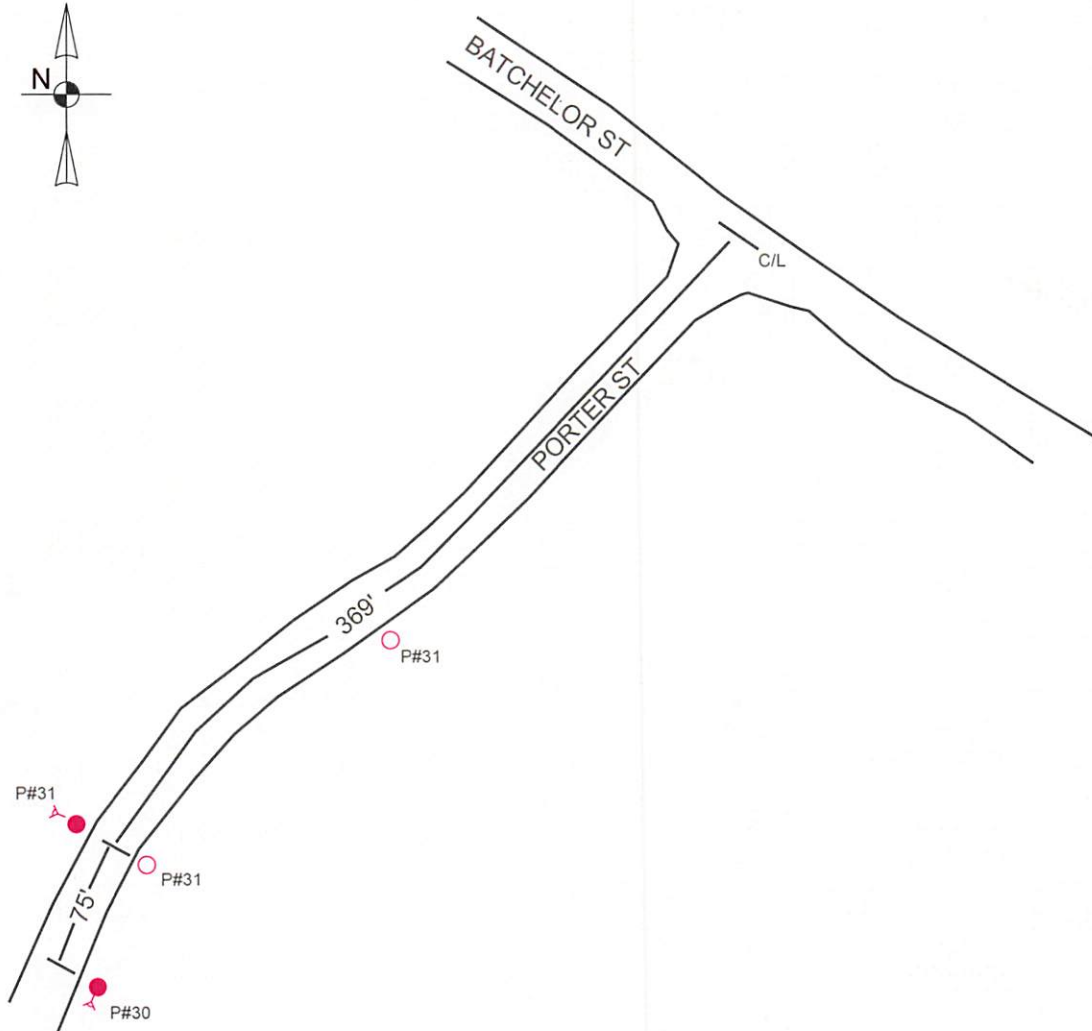
Your petitioner agrees to reserve space for one cross-arm at a suitable point on each of said poles for the fire, police, telephone, and telegraph signal wires belonging to the municipality and used by it exclusively for municipal purposes.
