The Select Board will hold a Public Hearing on Monday December 14, 2020 at 5:02 P.M. at the **Senior Center Building located at 10-B West State Street, Granby, MA to grant permission to National Grid to locate poles, wires, and fixtures, including the necessary sustaining and protecting fixtures, of said poles to be erected substantially in accordance with the plan filed herewith marked — *Pleasant St.-Granby Massachusetts*

1. Pleasant St. - National Grid to install (2) SO pole on Pleasant St. beginning at a point approximately 137 feet southeast of the centerline of the intersection of West State St. and approximately 126 feet ins a southeast direction. Install (2) stub poles and anchors to support reconducted poles # 39 and #40

Also for permission to lay and maintain underground laterals, cables, and wires in the above or intersecting public ways for the purpose of making connections with such poles and buildings as each of said petitioners may desire for distributing purposes.

The petitioner agrees to reserve space for one cross-arm at a suitable point on each of said poles for the fire, police, telephone, and telegraph signal wires belonging to the municipality and used by it exclusively for municipal purposes.

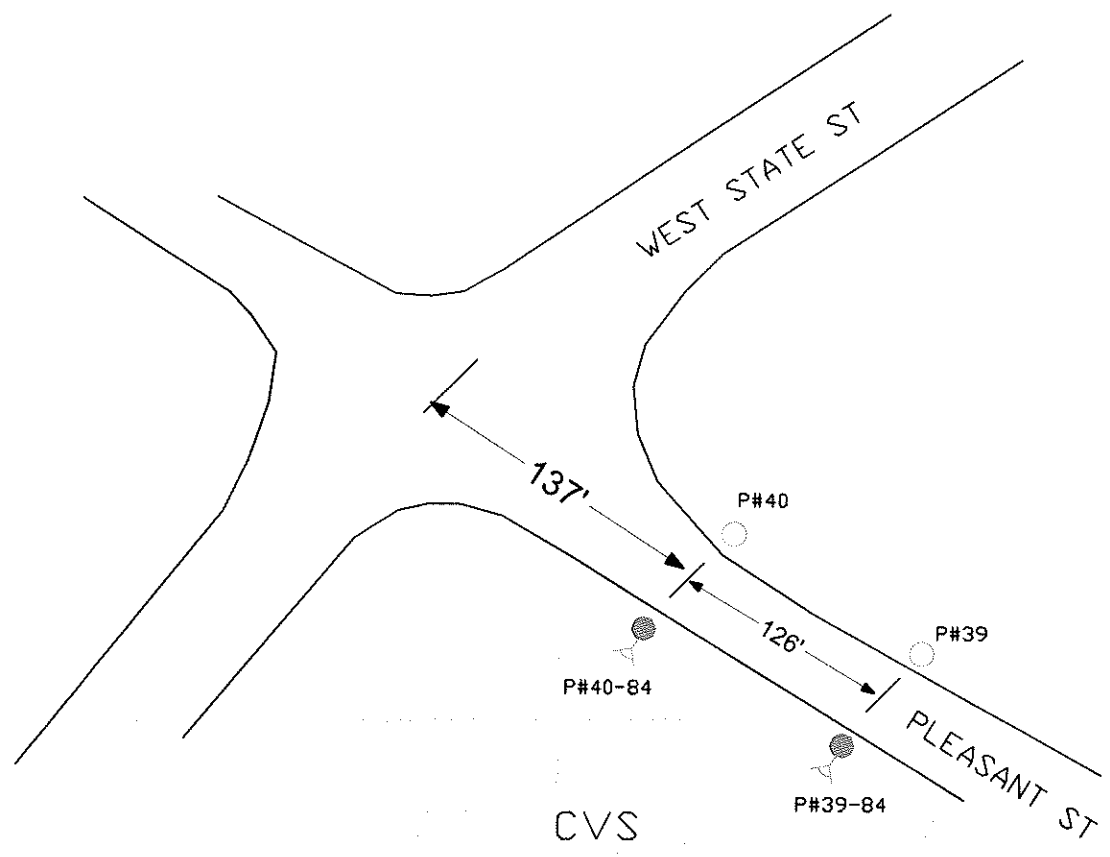
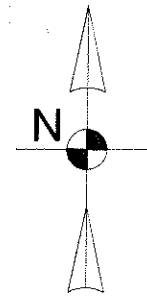
