GRANBY PLANNING BOARD PUBLIC HEARING NOTICE

In accordance with MGL Ch. 40A, Sec. 11, the Granby Planning Board will hold a public hearing on December 13, 2021, at 5:30 PM, at 1 Library Lane, Old Carnegie Library, Top Floor, Granby, MA. The nature of the hearing is to consider the petition of Gary Toth (Applicant/Owner), seeking Site Plan Approval under Section 6.3 of the Granby Zoning Bylaws regarding a proposed workshop/storage building, approximately 2,870 square feet, at 81 Pleasant Street, and known as Assessors' Map 3G-1-2 in the town of Granby, MA. The zoning district is General Business.
