 - MASS DOT has released entire project, including our proposed Water Pipeline
 - b. Temporary easement of 16 ft. all on the North Side for Mass DOT to park their vehicles.
 - c. All Building Owners have to connect to the water line and disable their current wells to avoid possible contamination.
