SUBJECT: SWAC 2016 Survey Results Report

The Solid Waste Advisory Committee (SWAC) was **established by the Selectboard in 2014 in response to concern among town residents over the closing of the landfill**. At the time the committee was formed, the town had entered into an initial 3-year contract for curbside solid waste collection and single stream recycling. In addition, the contract provides for curbside bulky waste disposal for a fee. This contract is funded by a property tax assessment of \$0.63 per thousand dollars assessed value, and is subject to the 2.5% tax levy increase each year. Additional revenue is generated through bag fees, with each resident limited to one 35 gallon trash container; and additional trash disposed of using garbage bags purchased by town residents. Trash is picked up weekly, and recyclables collected every other week.

SWAC proposed this survey to the Select Board last year. The initial version was met with opposition and a contentious discussion ensued. Changes were made to address the concerns of the Select Board and Town Administrator. Approval was not unanimous. The **survey was mailed along with the annual town census** at the beginning of the year.

Our committee has tabulated the results of the survey, analyzed the data, and summarized our findings. **Responses from all survey forms through March 16, 2016** have been input into an excel spreadsheet, including written comments. The committee has been tracking and reviewing the results since mid-January. The results, our findings and conclusions; are summarized in this report.

All physical survey responses through March 16, 2016 are provided. SWAC requests that the Select Board advise SWAC where the responses should be stored to ensure compliance with all state regulatory requirements.

We thank the Select Board for their support and believe that the results will provide valuable feedback from town residents as we approach the final year of our contract with Republic Services.

1. Purpose of Survey

Now that we are 18+ months into our migration from transfer station to curbside pickup, this survey provides valuable feedback from town residents. The genesis of this survey came out of the committee's desire to determine whether the gap programs (Special Collection Days) and curbside pickup are meeting the needs of our citizens.

The purpose of this survey is to:

- gauge the level of satisfaction among town residents with current services
- identify unmet needs of town residents
- understand concerns regarding how services are paid for
- determine which channels of communication town residents prefer
- obtain feedback about the future direction of solid waste disposal options

The results of this survey provide a barometer by which town management can measure current strategies and policies against the needs and desires of the community.

2. Survey Methodology & Tabulation

Survey containing 7 questions was included in the annual town census mailing in January 2016. The census is mailed to all households in the town. According to Kathy Kelly-Reagan, Town Clerk; this year the census was mailed to 2,525 households, of which approximately 100 census envelopes were returned by the Granby Post Office as undeliverable.

Since legal mandate requires all households respond to the annual town census, piggybacking the SWAC Survey with the annual town census mailing was expected to boost response rates. We believe it did.

Survey results were tabulated as is. Although most survey respondents answered all questions, some respondents did not answer every question. Survey respondents sometimes only answered part of the question. In questions where comments were solicited, some respondent did not check the box; but wrote a comment. In cases like this, we did not count the choice because the box was not checked; but we did capture the comment.

Both the raw value/number and the percentage the response to each answer represents to the total number of survey respondents have been tabulated. With almost one-third of the households responding, the confidence level as to the accuracy of each response is very high; and statistical variation is within a standard deviation.

3. Summary of Findings

We have summarized the results of the survey below, providing an overview of our findings. Each percentage or proportional relationship is calculated based upon the total number of responses.

- 32.2% of all Granby households responded to the survey
- 75.3% of survey respondents used the transfer station in the past
- By over a **2-to-1 margin, town residents are satisfied** with the current curbside pickup program
- **30% expressed dissatisfaction** with the current program. Reasons for dissatisfaction:
 - 20.0% want to have increased opportunities to recycle
 - o 15.2% want to have the trash can volume/weight limit increased
 - o 15.0% want to change to a flat fee service
 - 3.1% want to change the tax funded service
- Residential preferences moving forward gauges interest in each possible option:
 - o 45.7% want the town to negotiate a new curbside pickup contract
 - 21.4% want a new transfer station
 - 10% want to leave the responsibility to each individual household
 - 7.4% want to co-op/yoke with another town
 - o 15.5% no opinion
- 36.0% of all households participated in one or more special collection days. Of these participants:
 - 42.3% participated in one or more yard waste days
 - 41.6% participated in the bulky waste day
 - 68.9% participated in the hazardous waste day

- Communication with town residents remains a challenge and the town website and cable TV channel remain the most underutilized. Different residents prefer different channels of communication.
 - 38.9% heard about special collection days from the Street Sign on 202
 - 37.1% found out from the robo call program
 - o 21.1% by word of mouth
 - 16.2% from the senior newsletter
 - 13.5% from their OTT monthly phone bill
 - 8.3% from the town website
 - 7.0% from town Cable TV channel
- 52.2% of the survey respondents want more frequent special collection days, of which:
 - 38.8% want more yard waste days
 - 78.3% want more bulky waste days
 - o 60.0% want more hazardous waste days

4. Recommendations based upon Survey Results

This survey provides valuable feedback from town residents. The findings of this survey should be incorporated in future decisions as to the direction of solid waste disposal and recycling. SWAC recommends the following based upon the results of the survey:

- Continue with curbside pickup and negotiate the best deal possible, expanding services where possible without an increase in overall costs.
- Continue and expand Special Collection Days, utilizing all forms of communication to ensure town members know of the dates. Announcing the dates at annual town meeting would be beneficial.
- Extend recycling opportunities, expanding the number of Bulky Waste Days and the materials that can be disposed of; including by products like coal ash.
- Continue funding solid waste disposal through current property tax assessment; not increasing the rate and reducing the rate base if possible.

A small percentage of property owners are negatively impacted by the current funding structure. It is important to be sensitive to their concerns. However, we see no opportunity to mitigate their tax rates without creating a new tax class; which would result in an increase in the tax rate for funding solid waste disposal and recycling.

5. Survey Questions

The survey was printed together with Granby 250th Announcement on a single side, and consists of 7 questions. Comments were invited. Town resident responses provide context to the survey results.
