

**COMMONWEALTH OF MASSACHUSETTS

To one of the constables of the Town of Granby in the County of Hampshire:

Greetings:

In the name of the Commonwealth of Massachusetts you are hereby directed to notify and warn the Inhabitants of said Town, qualified to vote in elections and town affairs, to meet at the Granby Junior-Senior High School on East State Street in said Town on Monday, the seventeenth day of June next, at 7:10 P.M., then and there to act on the following articles, to wit:

ARTICLE 1. To see if the Town will vote to amend the Volume II of the Bylaws of the Town of Granby by striking out the existing Chapter XIX Personnel Bylaw and inserting the new Chapter XIX Personnel Bylaw as presented at the bylaw hearing held on April 17, 2013, or take any other action in regards thereto.

(Copies of the new Personnel Bylaw are available in the SelectBoard's Office)

ARTICLE 2. To see if the Town will vote to transfer from Free Cash the sum of \$116,055.20 for the purpose of funding account #30-300-5301-ART STM 05/11/2009 Article #07 Feasibility Study, or take any other action in regard thereto.

ARTICLE 3. To see if the Town will vote to authorize and appropriate, borrow or transfer from available funds the sum of \$15,021.65, or a greater or lesser amount, for the purpose of funding the Computer expense budget for FY2013, or take any other action in regards thereto.

ARTICLE 4. To see if the Town will vote to authorize and appropriate, borrow or transfer from available funds the sum of \$30,000, or a greater or lesser amount, for the purpose of funding the Veterans Services expense budget for FY2013, or take any other action in regards thereto.

ARTICLE 5. To see if the Town will vote to authorize and appropriate, borrow or transfer from available funds the sum of \$14,215.54, or a greater or lesser amount, for the purpose of funding the Public Buildings expense budget for FY2013, or take any other action in regards thereto.

ARTICLE 6. To see if the Town will vote to authorize and appropriate, borrow or transfer from available funds the sum of \$15,973, or a greater or lesser amount, for the purpose of funding the Police Department Personal Services budget for FY2013, or take any other action in regard thereto.


ARTICLE 7. To see if the Town will vote to authorize and appropriate, borrow or transfer from available funds the sum of \$7,692, or a greater or lesser amount, for the purpose of funding the Dispatch Department Personal Services budget for FY2013, or take any other action in regard thereto.




